TO THE RESIDENT, QUALIFIED ELECTORS OF SAID DISTRICT:

TAKE NOTICE that an election will be held in said District as provided in an ORDER CALLING A BOND ELECTION duly passed by the Board of Trustees of said District, which Order is substantially as follows:

ORDER CALLING A BOND ELECTION

WHEREAS, this Board of Trustees of Blue Ridge Independent School District (the "District") deems it advisable to call the election hereinafter ordered; and

WHEREAS, such election is subject to the provisions of Section 45.003, Texas Education Code, and the District is contracting with each of Collin County, Texas and Fannin County, Texas (together, the "Counties") for the administration of the election pursuant to interlocal agreements with the Counties (individually, an "Election Contract", and together, the "Election Contracts") and the Texas Election Code (the "Code"); and

WHEREAS, the Counties, acting through each of their elections administrator or county clerk (collectively, the "Election Administrators") in accordance with each respective Election Contract, will provide for the administration of the election on Election Day (defined below) and during the period of early voting for the election to serve voters of the District that reside in each respective County; and

Whereas, the election shall be conducted as a joint election with other political subdivisions in Collin County in accordance with Chapter 271 of the Code and, in particular, with the City of Blue Ridge, in satisfaction of the requirement set forth in Section 11.0581(a)(1), Texas Education Code; and

WHEREAS, it is hereby officially found and determined that said meeting was open to the public, and public notice of the time, place and purpose of said meeting was given, all as required by the Government Code, Chapter 551.

THEREFORE, BE IT ORDERED BY THE BOARD OF TRUSTEES OF BLUE RIDGE INDEPENDENT SCHOOL DISTRICT:

1. An election shall be held between the hours of 7:00 A.M. and 7:00 P.M. on May 4, 2019 ("Election Day"). Election Day voting is to be administered by the Counties, as provided by Chapter 271 of the Code and the respective Election Contract. Voting on Election Day shall occur during the hours and at the designated polling places designated by the Counties in the Election Contracts and as set forth in Exhibit "A" attached hereto, which exhibit shall be modified without further action of the Board required, to include additional or different Election Day polling places required to conform to the Election Contracts and the Code.

2. The early ballot board, election administrator, early voting judges, early voting clerks and all other election officers designated pursuant to law and the Election Contracts by the Counties and the District are hereby appointed and confirmed to hold said election at said polling places and all early voting places. The Elections Administrators and each respective County may employ other personnel necessary for the proper administration of the Election, including such part-time help as is necessary for the Election, to ensure the timely delivery of supplies during early voting and on Election Day. In addition, District employees are authorized to assist the County Clerk of Fannin County in her administration of the election for District residents who reside in Fannin County.

3. Early Voting is to be administered by the Counties, as provided in each respective Election Contract, and early voting shall be conducted by personal appearance at the locations and during the period early voting is required or permitted by law, being April 22, 2019 through April 30, 2019, on the dates and at the times as set forth in Exhibit "B" attached hereto, which exhibit, shall be modified without further action of the Board required, to include additional or different early voting polling places, dates and times as may be necessary or required to conform to the Election Contracts and the Code.

4. All resident, qualified electors of said District shall be entitled to vote at said election.

5. At the election the following PROPOSITION shall be submitted in accordance with law:

BLUE RIDGE INDEPENDENT SCHOOL DISTRICT PROPOSITION A

Shall the Board of Trustees of Blue Ridge Independent School District be authorized to issue the bonds of the District, in one or more series, with the bonds of each such series or issue, respectively, to mature serially within not to exceed thirty-one years from their date, and to be sold at such prices and bear interest at such rates as shall be determined within the discretion of the Board of Trustees, in the aggregate principal amount of \$25,000,000 for the purpose of the acquisition, construction and equipment of school buildings in the District, with the bonds to mature, bear interest, and be issued and sold in accordance with law at the time of issuance; and shall the Board of Trustees be authorized to levy and pledge, and cause to be assessed and collected, annual ad valorem taxes, on all taxable property in the District, sufficient, without limit as to rate or amount, to pay the principal of and interest on the bonds and the cost of any credit agreements executed in connection with the bonds?

6. The official ballots for the election shall be prepared in accordance with the Texas Election Code so as to permit the electors to vote "FOR" or "AGAINST" the aforesaid PROPOSITION with the ballots to contain such provisions, markings and language as required by law, and with such PROPOSITION to be expressed substantially as follows:

7. In accordance with the provisions of Section 3.009(b), Texas Election Code, it is hereby found and determined that:

- (a) The proposition language that will appear on the ballot is set forth in Section 6 hereof.
- (b) The purpose for which the bonds are to be authorized is set forth in Section 5 hereof.
- (c) The principal amount of the debt obligations to be authorized is set forth in Sections 5 and 6 hereof.
- (d) As set forth in Sections 5 and 6 hereof, if the bonds are approved by the voters, the Board of Trustees will be authorized to levy annual ad valorem taxes, on all taxable property in the District, sufficient, without limit as to rate or amount, to pay the principal of and interest on the bonds and the cost of any credit agreements executed in connection with the bonds.

(e) Based upon the bond market conditions at the date of adoption of this Order, the maximum interest rate for any series of the bonds is estimated to be 4.50% as calculated in accordance with applicable law. Such estimate takes into account a number of factors, including the issuance schedule, maturity schedule and the expected bond ratings of the proposed bonds. Such estimated maximum interest rate is provided as a matter of information, but is not a limitation on the interest rate at which the bonds, or any series thereof, may be sold.

(f) As set forth in Section 5 hereof, if the bonds are approved, they may be issued in one or more series, to mature serially, over a period not to exceed thirty-one years.

(g) The aggregate amount of the outstanding principal of the District's debt obligations (all of which are secured by an unlimited tax levied for debt service purposes) as of the beginning of the District's 2018-19 fiscal year was \$13,740,000.00.

(h) The aggregate amount of the outstanding interest of the District's debt obligations (all of which are secured by an unlimited tax levied for debt service purposes) as of the beginning of the District's 2018-19 fiscal year was \$6,453,525.00.

(i) The ad valorem debt service tax rate for the District at the date of adoption of this Order calling the election is \$0.40149 per \$100 of taxable assessed valuation.

8. The Board of Trustees hereby authorizes the Superintendent, President, Vice President or the Secretary of the Board of Trustees to execute or attest on behalf of the District the applicable Election Contracts with each County.

*VISTO que esta Junta de Regentes del Distrito Escolar Independiente de Blue Ridge (el "Distrito") considera aconsejable convocar a la elección que se ordena a continuación; y*

*VISTO que dicha elección está sujeta a las disposiciones de la Sección 45.003 del Código de Educación de Texas, y que el Distrito está contratando tanto con el Condado de Collin, Texas como con el Condado de Fannin, Texas (conjuntamente, los "Condados") para la administración de la elección conforme a acuerdos interlocales con los Condados (individualmente, un "Contrato Electoral"; conjuntamente, los "Contratos Electorales") y el Código Electoral de Texas (el "Código"); y*

*VISTO que los Condados, cada uno por medio de su administrador de elecciones o secretario del condado (conjuntamente, los "Administradores de Elecciones"), de acuerdo con su respectivo Contrato Electoral, proveerán para la administración de la elección el Día de las Elecciones (definido más adelante) y durante el periodo de votación adelantada para la elección para servir a los votantes del Distrito que residen en cada respectivo Condado; y*

Visto que la elección se llevará a cabo como una elección conjunta con otras subdivisiones políticas en el Condado de Collin de conformidad con el Capítulo 271 del Código y, en particular, con la Ciudad de Blue Ridge, en cumplimiento del requisito establecido en la Sección 11.0581(a)(1) del Código de Educación de Texas; y

VISTO que por este medio se determina y declara oficialmente que dicha sesión estaba abierta al público, y que se dio aviso público acerca del horario, el lugar y el propósito de dicha sesión, todo como se requiere en el Capítulo 551 del Código de Gobierno.

**POR LO TANTO, LA JUNTA DE REGENTES DEL DISTRITO ESCOLAR INDEPENDIENTE DE BLUE RIDGE ORDENA:**

1. El 4 de mayo de 2019 (“Día de las Elecciones”) se celebrará una elección, entre las 7:00 a.m. y las 7:00 p.m. La votación el Día de las Elecciones será administrada por los Condados, de conformidad con el Capítulo 271 del Código y el Contrato Electoral respectivo. La votación el Día de las Elecciones se llevará a cabo en los horarios y en los sitios de votación designados establecidos por los Condados en los Contratos Electorales, como se establece en el Anexo “A” a continuación, el cual deberá modificarse, sin requerirse acción alguna de la Junta, para incluir sitios de votación adicionales o diferentes para el Día de las Elecciones requeridos para cumplir los Contratos Electorales y el Código.

2. Por este medio se nombra y confirma la junta de votación adelantada, el administrador de elecciones, los jueces de votación adelantada, los secretarios de votación adelantada y todos los demás funcionarios electorales designados de acuerdo con la ley y los Contratos Electorales por los Condados y el Distrito para celebrar tal elección en dichos sitios de votación y en todos los sitios de votación adelantada. Los Administrador de Elecciones y cada Condado respectivo podrán emplear todo otro personal necesario para la administración apropiada de la Elección, incluyendo toda ayuda a tiempo parcial como sea necesaria para la Elección, para asegurar la entrega oportuna de suministros durante la votación adelantada y el Día de las Elecciones. Además, los empleados del Distrito están autorizados a asistir a la Secretaria del Condado de Fannin en la administración de la elección para los residentes del Distrito en el Condado de Fannin.

3.
